Initiatives included a pre-entry coalition, participatory defense hubs, and influencing the driving equity bill. Collaborating with Power Live Free, I educated the community on police accountability. Partnering with the NFL and Big Brother Big Sister, I brought alternatives to youth in the justice system. I expanded our mission to advocate beyond the courtroom, emphasizing empowerment, collaboration, and challenging systemic narratives for justice.

As Chief Defender, I transformed the public defender's role from reactive to proactive, enhancing public safety. A key achievement is the establishment of participatory defense hubs in Philadelphia. These hubs, utilizing trained community volunteers, provide crucial support, perspective, and insights for individuals navigating the justice system. This collaborative approach has proven effective in preventing wrongful convictions, ensuring fair responses to behaviors, and creating alternative options that leverage community resources.


37. What can you do to improve the quality of life of the average Black 22 year old in your district?
