15. Please describe the general background of your public service during your professional career.

For 23 years, I have navigated the intersection of the law and politics in order to improve people's lives. I have built the kinds of coalitions that the Attorney General must assemble because I lead with the right vision and values as well as an understanding of political and practical realities that can often frustrate change.

Most recently, I served as the County Solicitor in Bucks County, where I was confirmed by a unanimous and bipartisan vote of the Bucks County Commissioners. I am proud of the recognition that I received for my service, including the Pennsylvania Bar Association's Government Lawyer of the Year Award and the County Commissioners Association of Pennsylvania's Outstanding Solicitor Award. The long list of our reforms and accomplishments includes fair chance and equal pay hiring policies, creating a pardons and expungement unit in the Public Defenders Office, a bill of rights for car buyers, becoming the first county to sue Big Tech for targeting our kids, suing companies who polluted our water, and stopping Donald Trump from throwing out our votes. With each of these initiatives, I not only ensured that our legal and practical strategy was sound, I helped ensure that we had bipartisan support for all of them. By finding ways to earn the support of the Republican elected officials, we ensured that arguably "progressive" changes were enacted without public opposition and implemented in ways that will stand the test of time. I am also proud that Bucks County is the largest county in Pennsylvania to receive a full share of its potential payout from Big Pharma companies who agreed to pay millions for their role in the opioid epidemic. Because I understood not only the legal issues but also the political realities necessary to secure the sign-off of other political leaders, the people in our County will have millions more in resources to help address our crisis of addiction.

I had a similar approach during my 16 years as a prosecutor, building coalitions to address challenges such as gun violence in a holistic and comprehensive way. And my experience in politics has only strengthened my ability to get things done. When I served as the first Board President of LEAD PA, I built meaningful relationships with leaders and stakeholders across Pennsylvania. My work as a Democratic committeeperson in Philadelphia building bridges between veteran members who valued tradition and newer members helped elect my brother Tarik as Pennsylvania's first Pakistani-American legislator (and among the first two South Asians to serve in the PA House). As a County Solicitor, I not only built political relationships with Bucks County, but I forged strong bonds with solicitors and commissioners across Pennsylvania.

16. Please describe your accomplishments in promoting the concept of equity for all people.

Throughout my 24 year legal career, summarized above, I have viewed my mission through a lens of promoting diversity, inclusion and equity. I will highlight during my recent tenure as Bucks County Solicitor three accomplishments that I'm particularly proud of: 1) authoring Bucks County's fair chance ("ban the box") and equal pay hiring policies, 2) creating a pardons and expungement unit in the Public Defender's Office, and 3)creating the first county law department to become Mansfield-certified for DEI best practices.

17. Please describe any particular qualification you possess which was developed either through your career or in your community that would enhance your ability in the office you seek.

Over the course of my legal career, I have developed substantial experience as a criminal and civil prosecutor while also gaining experience defending both civil and criminal actions. Aside from my criminal experience, I have worked closely with the Attorney General's Office on numerous projects including election litigation, consumer protection, and trusts and estates issues. And I have extensive leadership experience, particularly with respect to recruiting, managing and leading attorneys in the public interest.

I have the strongest prosecution experience of any candidate in the field. Over 16 years as a prosecutor - first as a Philadelphia Assistant District Attorney and then as an Assistant United States Attorney in the Eastern District of Pennsylvania, I criminally prosecuted a wide variety of offenses, including sexual assault, political corruption, and economic crimes. While I built complex cases by working with excellent police officers, I also prosecuted bad cops and promoted best practices for rooting out corrupt police officers while I served as a federal prosecutor. When I became Bucks County Solicitor, I leveraged my credibility and experience as a former prosecutor to create a Pardon and Expungement Unit, enact a ban the box hiring policy, and increase funding for the Public Defender's Office (which I oversaw administratively).

I also have the strongest experience in civil justice, consumer advocacy and defending democracy. As both a private sector attorney and county solicitor, I brought major claims against corporations that harmed Pennsylvania communities, including the Big Pharma companies who fueled an opioid crisis, the Big Tech companies who fueled a youth mental health crisis, and the PFAS manufacturers who polluted our water with forever chemicals. While overseeing Bucks County's Consumer Protection Director, I helped enact reforms such as Pennsylvania's first used car Lemon Law. And as County Solicitor, I have taken unprecedented steps to protect our fundamental rights when they came under attack, including the right to abortion, the right to a clean environment, and the right to vote.

18. Please describe any particular qualification you possess which was developed either through your career or in your community that would enhance your ability to serve in government.

My lifetime of engaging with immigrant communities will also enhance my return to government service. As the son of a Pakistani immigrant, I have a lifelong commitment to improving linguistic and cultural accessibility for New Americans and others for whom English is not a first language. Most recently, this has been reflected in my service on the Governor's Advisory Commission for Asian Pacific American Affairs (where we promoted language access for Pennsylvania voters from immigrant communities), my work creating Bucks County's New Americans Advisory Commission, and ensuring that Bucks County's consumer protection department was hearing the concerns of Latin/Hispanic consumers. We are all better off when we ensure that all voices in our communities are heard, and we proved that point in Bucks County when we showed up to hear the concerns in Spanish-speaking communities about exploitation by used car

dealers. To address those concerns, I authored Pennsylvania's first-ever used car Lemon Law, which passed with bi-partisan support in Bucks County, ensuring that all consumers here now have a bill of rights when they buy a used car. As Attorney General, I will continue to lead by example on language access, which is important for accessing basic government services as well as voting access and educational resources. And through the power of my office, I will be proactive in ensuring that each County complies with the language minority provisions of the Voting Rights Act as well as any other laws requiring the Commonwealth to expand language access programming.

20. If elected, what are your top

Aside from ensuring that the Attorney General's Office promotes public safety in all 67 counties, we will have three immediate priorities on Day One.

First, we will need to protect Pennsylvanians from attacks on our rights, including reproductive rights and the right to vote which will be under assault by a battery of legal challenges by election deniers in January 2025.

Second, we will create Pennsylvania's first-ever Housing Justice Unit to ensure that the Attorney General's Office is doing its part to address the housing crisis we currently face. After the general election, I plan to convene a transition team with stakeholders, including Senator Nikil Saval and his staff, who will advise me on the formation of this unit so that we can hit the ground running on Day One. There's no time to waste. Third, we will reimagine the Environmental Crimes Unit as an Environmental Justice Unit to ensure that we are thinking more broadly about all of the ways we can use the awesome power of our office to protect the health and safety of all Pennsylvanians – even what requires taking other governmental entities to court. Pennsylvania's Environmental Rights Amendment is a superpower for an Attorney General who knows how to use it, and I don't want to waste any time getting to work to save our planet.

13. What, if any, is the biggest threat to voting rights in Pennsylvania? *

The biggest threat to voting rights in Pennsylvania is election deniers taking over county governments. As Attorney General, I will be ready to take these people to court to force them to do their jobs.

In 2020, as Bucks County Solicitor I served on the front lines protecting the right to vote when it came under attack – first when "Judicial Watch" tried to purge voters from our rolls, then when Republican House Speaker Mike Turzai fought our efforts to count mail-in ballots, and then again when Donald Trump and his goons tried to steal the election through bogus claims of election fraud. Attorney General Shapiro's office provided a firewall against all of these attacks, and the Republicans now want that firewall gone. I'm not going to let that happen.

In a sense, it was relatively easy in 2020, when winning election challenges only required us to beat back absurd legal theories concocted by the likes of Rudy Guiliani. Since then, however, the forces opposed to democracy have organized and infiltrated local governments, and to defend democracy again we need to get this right on Day One.

After the general election, I plan to convene a transition team with stakeholders, including Senator Saval and his staff, who will advise me on the formation of a Housing Justice Unit so that we can hit the ground running on Day One. Pennsylvania's first-ever Housing Justice Unit would use the Attorney General's Office's available tools (like civil complaints, consumer protection actions, and criminal prosecutions) to address the housing crisis, which takes different forms through Pennsylvania's diverse communities. Urban areas need an Attorney General to stop predatory landlords from exploiting tenants, to prevent unfair evictions, and to abate lead contamination that endangers children. Suburban areas need the AG to take on overseas investors who prevent families from obtaining attainable housing by treating housing as another commodity instead of a human right. And rural areas need an AG who will address the power imbalance between mobile home areas and those who own the land on which their homes are located. These issues are complicated, interrelated, and require a holistic approach to solve. And there's no time to waste.

32. According to the FBI, White Supremacy is on the offensive both in government and in our socio-political rhetoric. What can be done to protect communities of color, LGBTQ folk, Women, Immigrants and other at risk communities from this very real threat?

With white supremacists actively trying to infiltrate police departments across Pennsylvania, we need a strong AG who will root these people out of police departments. I have an unmatched record of working well with good police officers while holding bad cops accountable. I've prosecuted and proactively investigated police officers and will use the power of the Attorney General's Office to root out police corruption, especially where local DAs have failed to hold them accountable.

Throughout my career prosecuting hate crimes, sexual assault, and domestic violence, I fought for LGBTQ+ people who were targeted because of who they were. As Attorney General, I will continue to be a champion for these communities not only in the criminal justice system but in all areas where the Attorney General can seek justice. Rejecting anti-trans policies in other states and challenging anti-trans discrimination within our Commonwealth is the bare minimum that we can do here in Pennsylvania. And I would welcome any declaration by our governor or legislature that would support my resistance to subpoenas or extradition requests from states that are targeting trans people who come to Pennsylvania.

As a career prosecutor, I fought hard to balance the scales of justice as an advocate for vulnerable communities such as immigrants who were targeted for hate crimes, victims of human trafficking, or fearful of interactions with law enforcement - often because of their fear of deportation. As a County Solicitor and advocate for the AAPI community, I stood against the xenophobic policies of the Trump administration while also enacting a positive agenda of eliminating barriers to justice created by language inaccessibility and cultural insensitivity. As Attorney General, I will continue to be an ally of immigrant communities and protect them from the threats they are uniquely vulnerable to - including white supremacy.

33. How do you define community safety? How can your position work to keep the community safe?

I believe that the Attorney General needs to keep our communities safe from crime, corruption and attacks on our rights.

While public safety is an urgent threat that requires strong and bold leadership, protecting us from crime does not mean solving every problem with handcuffs. It means bring smart and value-based strategies that address immediate risks to our safety while investing in long-term strategies that address root causes

of crime. For example as a federal prosecutor, I did much more than use the power of arrest and prosecution as part of our strategy for reducing gun violence in Southwest Philadelphia. We were strategic in our focus – in most cases, interrupting escalating patterns of retaliatory violence – and provided pathways to redemption which helped us break up gun trafficking rings and close unsolved homicides. We invested time and resources to work with community stakeholders in supporting returning citizens with job opportunities, mentorship and positive incentives that empowered them to become productive members of society. And when I became Bucks County Solicitor, I leveraged my credibility as a prosecutor to create a Pardons & Expungements Unit in our Public Defenders' Office to further reduce barriers for those seeking employment and a fair shot at a second chance. All of this is part of a broader vision of safety that recognizes that we are safer when we invest in each others' success.

As detailed throughout this questionnaire, communities also need to be kept safe from corruption – not only corruption by government officials like the politicians and police officers I have prosecuted but also corruption corporate like the Big Pharma and Big Tech corporations I have taken on. And most immediately, the Attorney General must keep us safe from attacks on our rights, including reproductive, voting, and environmental rights. As Bucks County Solicitor, I went to the courts to protect these rights, and would continue this mission as Attorney General.

As Attorney General, I plan to lead a cultural change in how police misconduct is investigated and reviewed and how prosecutors maintain a healthy relationship with police departments while ensuring that there is accountability for police misconduct.

The LGBTQIA+ community deserves protection from discrimination because they are perpetually the targets of hate. I am a veteran hate crimes prosecutor who has advocated for the LGTBQIA+ community throughout my career. The most recent example of my advocacy hit close to home, when my friends, neighbors and fellow parents ousted the "Moms for Liberty" extremists who had taken over our kids' schools in the Central Bucks School District. After getting elected, these individuals unleashed an extreme and regressive agenda which included banning books and policies targeting and marginalizing trans students. On a grassroots level, I was part of a community of politically active parents in the Central Bucks School District. Together, we raised resources and supported candidates running to take back our schools from right-wing extremists. We were successful in ousting these officials and the slate which we helped elect immediately announced the rollback of the policies that unfairly and inappropriately targeted LGBTQIA+ students and literature.

During this fight, extremists targeted the Rainbow Room at the Salem Church in my neighborhood in an effort to intimidate kids who deserve a space safe. I joined dozens of my neighbors in a counter-protest to show solidarity with our LGBTQIA+ youth and their families. I immediately came under attack by Moms for Liberty and their extremist allies, who slandered me with hateful rhetoric. Neither I nor my allies flinched. To the contrary, I received strong encouragement from LGBTQIA+ elected leaders such as Rep. Izzy Smith-Wade-EI, who stated "Joe will protect the rights of marginalized communities. I'm in Joe's corner because he's the AG we all need."
